

Creating a safer social sector: what has been done and what is still to do?

On June 11 2019 the Charity Commission released its <u>inquiry report on Oxfam GB</u> following reports last year that some domestic and international charities had caused harm to those they work with and those they support. Page 33 of the summary report (or 134 of the full report) details the wider lessons for the sector.

This briefing outlines the cross-sector activity which has been taking place since the initial reports about Oxfam and other charities in February 2018. It will be updated as new work is launched.

What's coming up?

- Bond's leadership and culture group is working on a document that will help leaders identify indicators of an effective safeguarding culture and a tool to help them develop a positive safeguarding culture in their own organisations
- Both groups are looking at producing guidance on providing references
- Bond is working with DFID to create a reporting and complaints toolkit
- DCMS is working on a digital tool that will support charities in reporting, referring and handling safeguarding issues

DCMS and DFID are sharing information with each other to reduce examples of duplication in each work stream.

What is ACEVO going to do next?

We anticipate that our work in this area will be ongoing, at the very least covering the next few years. When we launched *In Plain Sight*, the research report on bullying in the charity workplace ACEVO carried out with Centre for Mental Health, we committed to certain next steps which can be found on our <u>website</u>.
