The Secretary of State for Digital, Culture, Media and Sport offers the Association of Chief Executives of Voluntary Organisations (ACEVO) in collaboration with Centre for Mental Health a "**Grant**" subject to your agreement to, and compliance with, the terms and conditions set out in this letter, [and its Annexes].

The maximum amount of Grant offered is up to £73,125, seventy three thousand one hundred and twenty five pounds. This will be paid in the following Tranches:

- up to £35,725, thirty five thousand seven hundred and twenty five pounds in financial vear 2018/19
- up to £37,400, thirty seven thousand and four hundred pounds in financial year 2019/20

The Grant is offered to you to contribute to certain expenditure ("**Eligible Expenditure**") where those costs are reasonably incurred by you in undertaking Protecting People from Harm ("**the Project**") as described in the **Project Description** in Annex 1.

ACEVO will inform the DCMS programme team in the first instance of any matter that comes to their attention which could have an adverse impact on the reputation of the Programme or their respective organisation or impact on delivery of the individual projects.
